Minor REVISION comments	The manuscript studies on the properties of gypsum based boards made from mixtures of wood and rice straw. The authors give moderate introduction regarding the composite panels. From the results of manuscript, it can be observed that the rice straw in wood chip/gypsum mixture helps to improve the insulation properties of the composites, but not their strength properties. On the other hand, the addition of rice straw to wood/gypsum mixture effects on extending hardening time.	
Optional/General comments	I would be glad to recommend the manuscript for publication, however the abstract is too long, which should be shortened as research article not as review article. Moreover, there are a lot of spelling and grammatical errors found in the manuscript, which should be corrected with the help of native English speaker.
