Compulsory REVISION comments	<p>In the introduction the author should mention how the work/study is divided (the structure) Inline 92-93 the author refers that emigration in Mali is very well-documented, but he does not make a state of art regarding this issue. It is not sufficient to make a endnote here making reference to an author. In this article and in this first part he/she should make a brief state of art of this issue.</p> <p>In line 107 it does not seems academic to put Mali's coordinates. It is relevant to say where it is geographically, but it is already too much to indicate the coordinates.</p> <p>In line 130 the author says that analysis the data in all the cercles of region of Sikasso, except Yorosso. But, it does not explain why it leaves out of the analysis this region.</p> <p>In line 200, it seems that there is a word missing "...there represent...." ?</p> <p>The conclusion much reflect the main results of the study. It seems that the author did not explore well enough all the results. The conclusion must be developed.</p>	<p>As you asked for the structure of the paper I have done it</p> <p>The rest of this paper is structured as follow: Section 2 presents the migration trends in Mali followed by the methods in section 3. Section 4 and 5 describe respectively the results and discussion, and the conclusion.</p> <p>In line 108 with coordinates have been corrected in "it is located between"</p> <p>The fact that Yorosso is not included in the analysis is due to the lack of accessibility.</p> <p>In line 201 "there" has been corrected in "they"</p> <p>The objective of this research was to identify the socioeconomic characteristics of migrants based on the push factors. For instance, to identify the characteristics of people who migrate due to bad weather or environmental challenges. Cross-sectional data was used for the analysis in this estimation. The use of multinomial logistic regression is the fact migration issue has many causes. From the result, the factors that significantly influenced migration were sex, age, and age squared, household size, labour constraint, and location. The probability of migration due to poverty or unemployment is very high than the other push factors such as environmental challenges. The fact to not overcome the environmental challenges is due to the vulnerability of the population. Therefore, the government should focus its effort on the first point of sustainable development goals that is "no poverty".</p>
