	1 - The Abstract (Summary) <u>doesn't</u> clearly and accurately describe the content of the article. There is no information regarding the type of study. (Check the Journal abstract example): <u>http://www.sciencedomain.org/journal/48/authors-instruction</u>	
	2 – Keywords: Immediately after the abstract, about 4-8 keywords should be given. In the manuscript there is only three keywords.	
	3 – Introduction: Write more about the different types of drugs: ecstasy, solvents, marijuana, alcohol, LSD, crack, among others. The problem (introduction) is significant and concisely stated. However, I suggest the use of more references, some cited by the author are relevant, but there are more recent references (with other populations), which he could use to add a greater impact to his study.	
	4 - The methods aren't described comprehensively.
