It acts as a maturing agent and dough conditioner by oxidizing the sulfhydryl groups of the gluten protein in flour into disulphide bridges making it less extensible and more elastic, this will make the dough viscoelastic such that it can retain the carbon dioxide gas produced by the yeast. The overall effect is to make bread rise in the oven, increase loaf volume and texture [17].</p>
