Compulsory REVISION comments	The work entitled "REDUCING ACRYLAMIDE EXPOSURE: A REVIEW OF THE APPLICATION OF SULFUR-CONTAINING COMPOUNDS - A CARIBBEAN OUTLOOK" was revised. The text is well written in English, but it makes an excessive use of the colon and semicolon. Regarding the content, I consider that the topic is relevant and may be attractive for readers in the fields of food science, food products, agricultural, and toxicology. However, there are some topics in which the idea is unclear or the discussion is left unfinished. Likewise, the chronological order of some (few) of the references cited is not the correct one. The lack of figures, graphs and tables makes reading the manuscript difficult. I suggest that these observations be taken into account so that the document can be accepted for publication in the journal.	ACCEPTED -The use of colons and semi colons have been edited throughout the text. - Refer to line 30 (Figure of Maillard reaction (General reaction pathway, and specific to Acrylamide formation) -Refer to line 24-26 (relocation of recommended text) -Refer to line 53 and 65 (relevant Caribbean data including foods available for consumption, the amount of foods produced and imported) -Line 75(Figure of Michael-type addition) -Refer to line 146 (correction made) -Paragraph from line 163-181 (paragraph restructure and reference re-arrangement). Line 163-170 are listed in chronological order of references' year of publication. Line 172 is not listed in chronological order. It is not inclusive of the research study of sulfur and nitrogen application on potatoes, but is inserted to highlight a consequence of sulfur's application to potatoes. - Refer to line 226 (correction made)
