When citing other works present the results that these authors obtained, in numbers.</p> <p>In the conclusion was presented a summary of the results, conclude his work with more clarity. What relevant information can this information provide?</p>	<p>Introduction: I have added references to the last two paragraphs according to your suggestion.</p> <p>Determination of ripening time: I have tried to correct this paragraph. Ripening time is determined from the day of ethephon application to attain the red color surface of tomato between 60% to 90% with the help of tomato colour chart .</p> <p>Titrateable acidity- I have corrected the volume made up and volume of extract taken in the equation.</p> <p>I have tried to discuss the results and cite other works present the results in numbers.</p> <p>I have tried to write summary in conclusion part with clarity.</p>
Minor REVISION comments	<p>The title is too long I suggest that it be rewritten as follows: Evaluation of the Effect of Ethephon in post-harvest of Tomato (<i>Lycopersicon esculentum</i>).</p> <p>In the introduction, the term "the tomato" repeats itself several times, try to substitute it with similar words, as for example: "The fruit".</p> <p>Still in the introduction, there is a lot of relevant information, however try to synthesize and organize the text better, the reading is confusing and tiring.</p>	<p>Ok Sir. I accept your suggestion. I have corrected the title name as Evaluation of the Effect of Ethephon in Postharvest Tomato (<i>Lycopersicon esculentum</i>)</p> <p>I have tried to substitute this tomato by "it and the fruit".
