Was its occurrence of mastitis at farm level such that if a farm had a positive case treated that constituted 1 entry or at the cow level so each cow with mastitis and treated was considered as a case. This will help clarify what the N was.	
	Line 54 include study area name Line 77 indicate what N=120 means	
	Lines 78-87 the descriptive language is strong and very emphatic. However, there are no statistical outputs to support the expressions used here. Consider carrying out additional statistics to show if the differences observed were statistically significant between the groups or not.	
	Include currency in Table 2 Include such as median and Inter Quartile Range or minimum vs maximum costs for the reader.	
	The manuscript provides relevant information to the dairy industry in India. It also provides a basis for policy implementation and capacity building reforms for the farmer and the vet service providers.
