There is a considerable need to improve the standard of English in the paper. A lot of remarks by the author require relevant references. Some have been mentioned in the reviewed manuscript. Although a good background of the Bangladesh farming system is made, the claims made require backing by a relevant respiratory (ies). Research question is not clearly cited. References of the studies have been given but most of them seem to be irrelevant with the current study. MILP models of other relevant studies may also be discussed in the introduction section. A schematic representation of the considered supply chain may be included for clarity. A schematic for the solution process including AMPL, Gurobi and Cplex may also please be added. Why is brand and bound algorithm used? Comments / studies on its effectiveness through comparison with other studies are not identified. Algorithm efficiency is not addressed. As no comparative studies have been referred, comments on conclusion of the study cannot be provided.
