This should be included in the title. Remove the last part in the title i.e "A <u>DISCUSS"</u> The Research Design section needs to be strengthened. The author needs to give more details on the type of literature used (for example, how many journal articles, books, articles in press, conference papers were reviewed?) which fields of study (Economics, Sociology etc?), from which continent(s) and countries, what was the subject matter?, from which period- is it from 1900 to date? Also, how did the author analysed the qualitative data and using which software/ package? Empirical review is weak. The author summarised other researchers' work on the subject matter in question. (S)he must critically review and discuss the findings. For example, a compare and contrast of results and trends of results as well as of methodologies (research designs) used- primary and second data used, sample size used, etc In my view, a review on entrepreneurship literature is incomplete without mentioning Schumpeter's seminal work on the subject matter. I recommend that the author reads a journal article entitled "Theories of Smallholder Agribusiness Entrepreneurship in the African Context: A critical review" by Benjamin Mudiwa
