The results in the "Abstract" are lengthy. Summarize and provide only important findings in it.</li> <li>In "Introduction" some statements are given without reference citation. Author is suggested to provide appropriate references for all statements except rationale and objective of the study which must be given without reference citation.</li> <li>Summarize the "Materials and Methods" and Mention the location and total time duration of research work with specific months and year in the start of "Materials and Methods". Author is advised to summarize the detail about existing protocols in "Materials and Methods". In "Data Analysis" Chi square cannot give significant difference between means; so give appropriate test.</li> <li>Author is requested to add subheadings in "Results" and not to repeat all the information of tables in their description; provide only main significant findings of the study in it. Moreover description of results must be completely synchronized with respective tables. Split tables 1 and 2 into five tables of community, gender, age, source of water and occupation.</li> <li>"Discussion" of the study is lengthy. Avoid over explanation and rewrite it in summarize and concise form only within 2 pages. Example; author found no significant difference between prevalence and intensity with respect to gender, but author still discussed gender related differences in paragraph 2 of the "Discussion".</li> <li>References must be listed at the end of the manuscript and numbered in the order that they appear in the text. Every reference referred in the text must also present in the reference list and vice versa. In the text, citations should be indicated by the reference number in brackets [3].</li> </ul>	
Minor REVISION comments	There are grammatical mistakes throughout the paper. So reread the article to minimize the typographical and grammatical errors, rephrase the sentences and use past tense throughout the manuscript. Avoid the Grammatical & spelling mistakes and personal pronounces (I, we, our etc), use past tense and third person throughout the manuscript.
