Please decide on one.</p> <p>Common chemical compounds in the middle of the sentence do not need capital on the first letter of the word. Zinc can be written as "zinc" or "Zn". https://www.aje.com/en/arc/editing-tip-capitalization-chemical-compounds/ Please recheck manuscript and correct for other common words.</p> <p>Also decide whether you want to use Zinc or Zn. For the sake of consistency, avoid switching the term or use both simultaneously.</p> <p>Please follows the biology rule of writing species name. <i>Corchorus olitorious</i> on first use, and <i>C. olitorious</i> thereafter.</p> <p>It was observed in introduction that the scientific name of the plant "Corchorus. Amaranthus"were not <i>italicised</i>.</p> <p>A few spelling mistakes were observed. Abstract: translocationing / Section 2.2.: deionzed /</p> <p>Was the experiment carried out in duplicate?</p> <p>If authors decided to abbreviate translocation factor as TF in the discussion section, author should do it on the first appearance of the word in section 2.2. Rules and using abbreviation. Abbreviations that are defined in the abstract will need to be defined again at first use in the main text. Terms that are already defined should not be redefined again otherwise it is a duplication of effort.
