<b>Compulsory</b> REVISION comments	<p>The MSPRI 50285 has some critical issues. Although the structure set for the survey can be considered valid, the number of patients included in the study remains poor. Since the type of treatment is not invasive and of little disturbance to the patient, it is appropriate to integrate the number of subjects into the survey.</p> <p>Furthermore, other factors, such as eating habits and taking pro IBS foods should be taken into consideration</p> <p>As suggested by the authors themselves, the lack of analysis on the type and fecal concentration of probiotics limits the consistency of data in the survey.</p> <p>The bibliography takes into consideration a few recent publications.
