Keywords are usually arranged in alphabetical</p> <p>In row 51, API, for the first time an abbreviation must be written in full followed by an abbreviation in parentheses In row 54 fine powder, how much size is the mesh? In row 57 Whiteman, should be Whatman ? In row 88 : 0,5 ml of Benedict's, Too small volume, should be 5 ml of Benedict's reagent In row 133 You should move the result to the next page so that the table is not interrupted. In row 147, 164 and 191 tabel and figure should be Tabel , Figure, capitalized each word. In row 165 and 192, I recommend that Tabel 3 and Table 5 move to the next page so that it is not interrupted</p>
